Inspection of type ZAS0, ZAS1, ZAS2, and ZAS3 elevator machines

Dear Sir/Madam,

We refer to our second letter of 19 July 2019, in which we announced that we would be summarising the quarterly, half-yearly and annual inspection and maintenance work in the "Instructions for the regular maintenance and testing of ZAS elevator machines" (A-TIA 19 07), for your support. The instructions also describe the measurement of the flank backlash as part of regular maintenance, which is why they have replaced instructions A-TIA18_11.

We would therefore ask you again to inform us - unless you have already done so - of the results of the inspections of the worm gear's screw connections.
